



Constructions in Spanish is the first book-length Englishlanguage volume in the field of usage-based and Cognitive Construction Grammar dedicated exclusively to Spanish. The contributions investigate a wide range of constructions from both a synchronic and a diachronic perspective, cutting across morphology, syntax, semantics and pragmatics. This volume features eight peer-reviewed chapters based on papers presented at the 33rd Annual Symposium on Arabic Linguistics, held at the University of Toronto in 2019. The chapters are divided into four sections: sociolinguistics, phonetics and phonology, syntax, and first language acquisition. They present research on relatively well-studied Arabic varieties such as the Moroccan, Jordanian, and Emirati varieties as well as understudied varieties such as the Palestinian dialects of Gaza and Jaffa, and the Saudi dialects of Al-Ahsa, Ha'il, and Faifi. The chapters address linguistic phenomena that range from language variation and change, the phonemic status and feature composition of rhotics, and the realization patterns of emphatic fricatives to the grammaticalization of aspectual markers, the syntactic and pragmatic aspects of post-wh-questions, and the acquisition trajectory of the definite article. The volume makes valuable descriptive and theoretical contributions to Arabic linguistics.

## The Ditransitive Alternation in Present-Day German

A corpus-based analysis

Hilde De Vaere

The ditransitive (or "dative") alternation is a much-studied phenomenon in contemporary linguistics. This monograph is the first to address the alternation in present-day written German from both a quantitative and qualitative perspective. As well as providing a corpus-based analysis of extensively annotated data and detailed statistical information. the book also contributes to the theory of language by developing an alternative framework to existing investigations of the alternation. It is shown that the alternation can be accounted for in a comprehensive way by adopting a threelayer approach to meaning and sense based on the work of E. Coseriu and S. Levinson. In this approach, a construction's language-specific encoded meaning is distinguished both from its conventional ("normal") uses and its discourse-specific interpretations in particular contexts. The monograph is likely to attract attention from researchers in the fields of German and English linguistics, general and contrastive linguistics as well as linguistic theory.

## General Phraseology Theory and Practice

Igor Mel'čuk

University of Montreal

This book presents a 100% novel approach to phraseology: A language-universal deductive calculus of all theoretically possible phraseological expressions (= phrasemes) is proposed, implemented in 51 rigorously defined notions. Nine major classes of phrasemes are established and illustrated: lexemic idioms (shoot the breeze), lexemic collocations (pay a visit; helicopter parents), lexemic nominemes (the Northern Palmyra) and lexemic clichés (What's your name?; to put it differently); morphemic idioms (forget), morphemic collocations (Londoner ~ Muscovite), morphemic nominemes (Greenland) and morphemic clichés (antidepressant); and syntactic idioms (Her be late?!?). An additional class of pragmatically constrained lexemic expressions is described: pragmatemes (No parking; At attention!; Roger.). Each phraseme class is supplied with precise methodology for a lexicographic description; a number of lexical entries for representatives of all classes are given. The language data come from English and Russian. General Phraseology: Theory and Practice is meant as a contribution towards the elaboration of a unified notional system for linguistics.





## The Spanish and the Portuguese Present Perfect in Discourse

Lukas Müller

University of Cologne

This monograph presents a theoretical and empirical study of the Spanish and the Portuguese Present Perfect (PP). The innovative claim is that the two tense forms operate in the field of tension between temporal quantification and temporal reference. Based on this approach, it presents the first in-depth study that explicitly takes into account the level of discourse. The following questions are investigated: How do the Spanish and the Portuguese PP interact with discursive factors, such as adjacent tense forms? What kind of discursive meaning do they generate? Which diachronic trends do their discourse functions reveal? It is argued that while the Spanish PP tends to a referential drift (traditionally labelled as an aoristic drift), the Portuguese PP tends to preserve and specialize its quantificational meaning. The book is of interest to all those working on the Present Perfect or generally in the field of tense and aspect in discourse.

### Serbian Clitics

Jasmina Milićević

Clitics, those "funny little words" like English contracted future tense and pluperfect tense/conditional mood markers ('ll and 'd) or French pronominal objects (le 'him', la 'her', lui 'to him/her', etc.), have long been a source of fascination for linguists. Lacking an inherent stress that characterizes "well-behaved" words, clitics prosodically depend on a stressed sentence element, called their host, which makes them look and, in some contexts, behave like affixes (parts of words). Some clitics, Serbian second-position clitics being the case in point, also obey stringent linear ordering rules, different from those holding for fully-fledged sentence elements. This monograph offers a comprehensive formalized description of second-position clitics in standard Serbian from the viewpoint of the Meaning-Text theory, an approach relying on syntactic dependencies and oriented towards speech production, which sets it apart from most contemporary frameworks. It will be of interest for general linguists, Slavists, and advanced learners of Serbian.




This scholarly edition invites us to reconsider our assumptions about the French language, by showcasing the oeuvre of one of the pioneers of diachronic Spoken French corpus linguistics, William J. Ashby, and the ground-breaking findings to come out of his influential Tours corpora (1976 & 1995), including two real-time studies appearing for the first time in English translation. To help readers visualize just how radically different the morphosyntax, morphophonology, and semantics of Spoken French are from French-on-the-page, the editor has developed a glossing framework, designed to capture the systemic, radicallyprefixal morphology of Spoken French and the variability of change-in-progress. The model, presented here and used to gloss the examples from the Tours corpus, is also suitable for corpustagging. The volume is organized into sections preceded by an Editor's note and followed by suggestions for further reading, and closes with an appendix of French corpora. This scholarly edition was written for advanced undergraduates, graduate students, and scholars in the field.





This volume on grammaticalization focuses on new theoretical and methodological challenges underpinning language change. It provides new approaches and insights deepening our understanding of the cognitive, pragmatic, and sociocultural mechanisms that trigger the formation and the change of grammars. In this volume grammaticalization is dealt with diachronically, synchronically and as a by-product of dialogic interaction. Another key feature of this book is language diversity; it includes studies on language families ranging from Niger-Congo, Koreanic, Japonic, Sino-Tibetan to Germanic and Romance. The novel aspects of grammaticalization addressed are new slants on the fundamental debate about grammaticalization as expansion vs reduction; the grammatical formation of ideophones; the semantic domain of fear as a source and a trigger of grammatical change, and many other aspects of semantic and morphosyntactic development.



## Wh-In Situ Licensing in Questions and Sluicing

Jun Abe

This book addresses the question of how in-situ wh-phrases are licensed from a minimalist perspective in which the basic assumptions about narrow syntax need to be reduced to the bare minimum. I propose that in-situ wh-phrases are licensed by way of either minimal Search or covert internal Merge: while in-situ wh-adjuncts are uniformly licensed by covert internal Merge, in-situ wh-arguments have a choice between the two options, depending on whether the licensing C head is overtly manifested. I also discuss sluicing, an ellipsis construction with a remnant wh-phrase, and address the question of how the remnant wh-phrase is licensed. I support the in-situ approach to sluicing, advocated in my previous book The In-Situ Approach to Sluicing (John Benjamins), according to which the remnant wh-phrase stays in situ. I argue against the more standard analysis, endorsing the main claim of this previous book that island repair by ellipsis is a myth.



## The Middle Voice and Connected Constructions in Ibero-Romance

A variationist and dialectal account

### Carlota de Benito Moreno

The reflexive constructions that are the focus of this book are the constructions broadly described with the term "middle": i.e., those that can appear in all persons, and in which the reflexive marker (RM) cannot be understood as a full referential pronoun. One goal of this study is to provide a corpus-based typology of middle and related uses that allow us to compare the behaviour of the RM in these constructions with previous typological accounts, where competing models (based either on changes of diathesis or on the semantics of the verbal event) can be found. A second goal is to shed light on the evolution of the different functions of the RM, by exploring the factors that affect its productivity, with a specific focus on those verbs where reflexive marking is most variable, that is, anticausative verbs and verbs with no change of valency. These reflexive constructions show a notable difference in productivity in Spanish and Galician. although the languages are closely related and contiguous. The languages are thus good candidates for a contrastive and variationist analysis serving these two goals. The semantic class of the predicate, its aspectual properties and the animacy of the subject are some of the most relevant factors that are taken into account to understand the motivations behind the presence or absence of the RM. By relying on a corpus of interviews from rural communities across peninsular Spain (except Catalonia), space as a relevant extra-linguistic variable is taken into account, helping uncover previously unknown geographical patterns.





Konkani is a modern Indo-Aryan language and a state language of the Indian state Goa. Until recently, it was considered a dialect of Marathi, but it is now considered an independent language. Konkani has several varieties, including the Manglore variety spoken in the south of Goa, the Gawdi variety spoken by the Gawda ethnic group, and the Goan (Panaji) variety. The latter is the focus of this description, and is the variety used in schools, media and state administration. The book provides a descriptive linguistic analysis of Konkani based on spoken and written data collected by the author during extensive fieldwork. The linguistic features of Konkani phonology, morphology, word-formation and syntax are described in detail, and where significant, compared with the Manglore and Gawdi varieties. Since Konkani is undergoing standardisation, and since it has close contact with Marathi, significant similarities and differences between the two languages are also discussed. Konkani has the honour of being the subject of the oldest European grammatical work on any Indian language: Thomas Stephens' Arte da Lingoa Canarim published in 1640. This grammar is thus the most recent addition to the long tradition of Konkani grammars.

## Granularity in the Verbalization of Events and Objects

A cross-linguistic study

### Katerina Stathi

The study departs from the observation that in expressing ideas, some languages encode more details than others. It investigates whether languages encode events and/or objects at a coarse-grained (e.g., put, glass) as opposed to a fine-grained (e.g., lay, wine glass) level systematically. The level of detail is termed granularity, which is viewed as a cline from fine-grained (semantic specificity) to coarsegrained meaning (semantic generality). Four languages are investigated: German, English, Greek, and Turkish. The study draws on elicited data from a naming task. The verbalization of events is based on event and object descriptions in selected semantic domains. The results reveal significant granularity effects between languages and language types (satellite-framed vs. verb-framed). The study is relevant for scholars interested in linguistic typology, lexical and semantic typology, contrastive linguistics, event representation, psycholinguistics, and cognitive semantics.

Rhetoric is intimately related to interaction and cognition. This book explores the cognitive underpinnings of rhetoric by presenting a case study of the rhetorical use of interactional structures, namely expository questions and rhetorical questions, in the classical Chinese tradition. Such questions are generally meant to evoke silent answers in the addressee's mind, thereby involving

a fictive type of interaction. The book analyzes fictive questions as intersubjective mixed viewpoint constructions, involving a viewpoint blend of the

perspectives of the writer, the assumed prospective readers, and possibly also that of the discourse characters. The analysis further shows that in addition to attention, other late developing human capacities such as mental simulation and perspective taking also have a pivotal role to play in rhetoric, on the basis of which a simulation-based rhetorical model of persuasion is proposed to account for meaning construction in rhetorical practices. The book will influence our understanding of rhetorical practices outside the Western tradition but within the framework of cognitive semantics.







## **Motion Metaphors in Music Criticism**

The book explores (1) the motivation of motion expressions in Western classical music criticism in terms of conceptual metaphors (Lakoff & Johnson, 1980, 1999) in two corpus studies, and (2) their perceived degree of metaphoricity among musicians and non-musicians in a rating study. The results show that while fundamental embodied conceptual metaphors like TIME IS MOTION certainly play a part in explaining why we speak of Western classical music as motion, it is the specific communicative setting of music criticism that determines the particular use of motion metaphors.

Furthermore, the perceived metaphoricity of musical motion metaphors varies with participants' musical background: musicians perceive musical motion expressions as more literal compared to non-musicians, showing that there are individual differences in the perception of metaphoricity.





This book offers a fresh take on several long-standing issues relating to the (non-)truth-conditional interpretation of epistemic, evidential, hearsay and attitudinal sentence adverbials. Drawing on a wealth of data from English and German, it shows for the first time that all four adverbial classes can have both truth-conditional and non-truth-conditional (parenthetical) readings. A novel account is presented according to which (non-)truth-conditional readings may arise at either the syntactic or the pragmatic level. Couched in relevance theory, the book also re-examines the explicature and illocutionary status of the adverbial qualification and the qualified proposition, and refines the notions of pointhood and at-issueness to provide an original information-structural analysis applicable to not just sentence adverbials but a range of other propositional qualifiers. Finally, the investigation identifies five factors affecting (non-)truth-conditional interpretation: linear position, prosody, the semantics of the adverbial, its information-structural properties and the wider context. Therefore, this volume suggests the name cofluency to reflect their potential functionality. Cofluencies are essential elements of multimodal chunks and multimodal patterns, and these are building blocks of a multimodal turn-taking mechanism for presentations. These concepts are illustrated and discussed based on excerpts from naturally occurring classroom data.

This volume offers a critical discursive-argumentative framework that scrutinizes the discursive construction and, moreover, the argumentative justification of authoritarian attitudes on newspaper front pages in highly polarized times of multiple 'crises' in Greece. At the same time, it aspires to outline novel research avenues for scholars working in the fields of critical discourse and argumentation studies, multimodality and communication studies, that go beyond the study of the meaning potential of multimodal artifacts and focus on the study of the argumentative inferences that are triggered by multimodal discourses in polarized contexts. It frames the theoretical discussion based on concepts such as Nikos Poulantzas' 'authoritarian statism' as well as Antonio Gramsci's 'hegemony' and 'intellectuals'. Methodologically, it draws on the agenda of multimodal critical discourse analysis, integrating principles and tools from social semiotics and (multimodal) argumentation studies with a particular focus on inference in argumentation.

The social impact of conspiracy theories is wide-ranging and their influence on the political life of many nations is increasing. Conspiracy Theory Discourses bridges an important gap by bringing discourse-based insights to existing knowledge about conspiracy theories, which has so far developed in research areas other than Linguistics and Discourse Studies. The chapters in this volume call attention to conspiracist discourses as deeply ingrained ways to interpret reality and construct social identities. They are based on multiple, partly overlapping analytical frameworks, including Critical Discourse Analysis, rhetoric, metaphor studies, multimodality, and corpus-based, quali-quantitative approaches. These approaches are an entry point to further explore the environments which enable the proliferation of conspiracy theories, and the paramount role of discourse in furthering conspiracist interpretations of reality.

## Towards an Atlas of the History of Interpreting

The aspiration of an Atlas is to cover the whole world, by compiling cartographical material representing territories from across the five continents. This book intends to contribute to that ideally comprehensive, yet always unfinished, Atlas with pieces gathered from all of the Earth's regions. However, its focus is not so much of a geographical nature (although maps and geographical reflections are not absent in its pages), but of a historical-analytical one. Each contributor has approached the specific spatial and temporal dimensions of their subject as perceived through their different methodological lenses. This multifaceted perspective, which is expected to provide fertile soil for future interdisciplinary research, has been possible thanks to a balanced combination of scholars from History and from Translation and Interpreting Studies.
